Exemptions from various requirements in Part 61 of the Civil Aviation Rules

applicable to pilots holding military qualifications

PURSUANT TO Section 37(2)(b) of the Civil Aviation Act 1990,

- I, <u>Christopher Martin Ford</u>, General Manager Aviation Infrastructure & Personnel, being satisfied that—
 - (a) pilots serving in the Royal New Zealand Air Force (RNZAF) or Royal New Zealand Navy (RNZN) who hold the relevant qualifications listed in Appendix A to this certificate have demonstrated skills and knowledge equal to or better than that required to meet the eligibility requirements specified in the Civil Aviation Rules listed in Appendix A for the grant of a pilot licence; and
 - (b) the risk to safety will not be significantly increased by the granting of this exemption,

HEREBY EXEMPT—

Pilots serving in the RNZAF or RNZN

who are seeking the grant of a pilot licence in accordance with Part 61

FROM-

those eligibility requirements in Part 61 of the Civil Aviation Rules listed in Appendix A.

PROVIDED THAT—

- (a) they hold the relevant qualifications listed in Appendix A to this certificate; and
- (b) are current on the relevant aircraft type at the time of issue of the licence

This exemption shall remain in effect unless withdrawn in writing by the Director.
